Be sure to take time off to be with your family. We need to remember that family comes first and we need to spend time with them relaxing and doing fun activities.



# **Texas FFA Update**

## **Constitutional Check-Up**

The official manual states that all members should have FFA knowledge and that all officers should have knowledge and understanding of the chapter, state and national constitutions. How would your students measure up on this one? What about you?

It's vitally important. I have had a number of calls this spring from administrators and concerned citizens regarding officer elections and other proceedings being conducted in a manner contrary to the local chapter constitution and bylaws.

It seems that the local advisor is unfamiliar with the governing documents of their own chapter. Things get a bit awkward when an administrator requests a copy of the constitution on file in our office and what is transcribed in that official document is not what is actually happening. This reflects poorly on a teacher, erodes public confidence and could result in having the results of an officer election or other action overturned.

Operating in a manner consistent with your governing documents will help keep you out of hot water on some issues, but the most important outcome is the instructional outcome. Ultimately, we are teaching young people how to run an organization and become equipped for citizenship and self government.

We suggest that you add to your list of summer plan items, an annual check-up on your governing documents: constitution and bylaws.

#### Annual Constitution & Bylaws Check-Up

(1) Request a copy of the state office file copy of your constitution/bylaws. You may have updated your constitution and bylaws since they were filed in Austin. If what is on file is different than your current documents, send in a new copy. Staff can scan and e-mail what is currently on file.

(2) From the Texas FFA website (Under resources>toolbox), download the document titled "Standards for governing documents." This checklist addresses all of the most features common to all constitutions and/or bylaws. All of these elements should be included in your chapter's constitution/bylaws.

(3) From the same page (chapter toolbox), download the sample constitution and bylaws. This is an editable MS Word document, so you can edit or copy from it as much as you would like. (4) Set aside ample time to meet with your officers to comb through the constitution and bylaws and develop recommendations for amendments. Your officers may decide that the changes are so sweeping, that a constitutional revision would be more appropriate. In this case, the officers would be proposing a new document that would supplant the old, rather than attempting to approve individual amendments in a piecemeal fashion.

(5) Decide what is appropriate for your governing documents. Provisions of the constitution and bylaws should provide the foundational framework for the organization. These documents should not be overly prescriptive and have language that is better delivered in chapter rules or policies. You do not want to include anything that may change or that may require a degree of flexibility operating within the school environment. Your constitution and bylaws may reference chapter policies that can be adopted and amended by a simple majority vote at a regular chapter meeting.

(6) Get approval. After your student leadership team (officers and other recognized leaders such as standing committee chairmen) approves the draft of the new or amended document(s) they should present them to local administrators. This demonstrates the handson student leadership development process to your school leadership and gives the administration a little bit of ownership in the process. It's a great experience for the students too! In one of your early meetings-August or September, the officers should post the new or revised documents as a discussion item. As a matter of procedure, the revisions should be presented at one meeting and then adopted at a subsequent meeting. In addition, the documents should be posted online and made as accessible as possible. Transparency is always best policy. Be sure that the adoption of the amendments or revised document is posted as an action item at the meeting at which the chapter will take action.

(7) Document action. Remember that whatever is not reflected in the minutes of a meeting, didn't happen. The chapter's minutes should reflect presentation of the constitution and bylaws at one meeting and their adoption at the subsequent meeting. The record should reflect that a quorum was present and the two-thirds vote required to adopt or amend a constitution. Usually, bylaws only require a majority. (8) Post, File and Teach. File your newly revised constitution and bylaws with the state office. This is a great insurance policy should your document be destroyed or lost. As a matter of record, you may want to include as an addendum, the minutes that reflect the presentation and adoption. Also, make sure your officers post the new document online and that all stakeholders have equal access. Furthermore, take some time in the FFA portion of your classes to teach your students about the local constitution and bylaws and why they are important, not just to the local FFA chapter, but to any organization. Your students may not immediately grasp or appreciate this information, but they will thank you later.

(9) Create Companion Policies, Procedures and Rules. Where your constitution references chapteradopted rules or procedures, be sure to get a head-start with your officers on the creation of these documents. For example, an officer application, testing and interview procedure and contract would not be included in the constitution and bylaws, but adopted as rules. Be sure that adoption of all such rules is reflected in the minutes.

(10) Adhere to your constitution and bylaws. We are a nation of laws, and it is vitally important that we teach and model the rule of law. We must also teach our students that if they dislike a particular law or rule, there is a procedure to change it. It's all about process and preparing our young people to be citizens of influence.

# **Texas FFA** Foundation Update

## **Texas FFA Foundation – Ambassadors 101**

A pretty common question I get from teachers is, "What is this Ambassador program? What kind of students are you looking for? What's in it for them?" All very good questions. The program was actually born out of a discussion between a former Foundation board member and FFA staff regarding student assistants to serve at convention with some additional training from that of a Courtesy Corp member. As the Foundation grew and our responsibilities to stakeholders during the convention grew, we knew we needed help. Our initial step included using some Courtesy Corp members to help us greet special guest. As our sponsors grew and philosophy of delivering exceptional customer service, the decision was made to create a group of Ambassadors to help tell the Texas FFA story to our special guests, sponsors and stakeholders who attend the annual convention.

One of the cornerstones to the Ambassador program is leadership development and training of the core value, servant leadership. Servant leadership is a philosophy and set of practices that enriches lives, builds better organizations and ultimately creates a better world. If all we do is take from the FFA, then when our students become citizens they take because that becomes the core value we've taught them. To the contrary, learning to serve in high school and help meet the needs of others will foster that same attitude, and ultimately assimilating itself into a core life philosophy of serving in a community where a person may live and work. Looking to meet the needs of others is not something you just do in four years of the FFA; the Ambassadors program is the minor leagues to prepare students for the big league of life and being ready to serve with purpose and meet the needs of a growing world.

While servant leadership is a timeless concept, the phrase servant leadership was coined by Robert K. Greenleaf in The Servant as Leader, an essay that he first published in 1970. In that essay, Greenleaf said: "The servant-leader is servant first... It begins with the natural feeling that one wants to serve, to serve first."

A servant-leader focuses primarily on the growth and well-being of people and the organization to which they belong. While traditional leadership generally involves the accumulation and exercise of power by one at the top of the pyramid, servant leadership is different. The servant-leader shares power, puts the needs of others first and helps people develop and perform as highly as possible.

The Foundation Ambassadors serve as hosts for special guests, sponsors and dignitaries on behalf of the Texas FFA during the largest youth led convention in Texas. Candidates apply through a competitive application process, with emphasis on FFA involvement, individual accomplishments and community service. Ambassadors receive extensive training to prepare them for their week of service. Each student Ambassador is assigned to a VIP serving as their respective agricultural science/FFA host for the week. In addition, the Ambassadors have a unique opportunity of experiencing firsthand the behind the scene complexities of convention week.



The 2014 Texas Young Farmer scholarship winners have been selected. Their pictures and brief summary will be in next month's newsletter and posted on our website. We had a great deal of qualified applicants this year. There were more entries this year than we have

had since 2005. We will be discussing possible changes to our scholarship application process at our next Young Farmer Board meeting on May 17. If you have any suggestions please let me know.

I would also like to encourage you to stop by the Young Farmers Booth at the Texas FFA Convention in Fort Worth, July 14-18, and the VATAT Conference in Abilene, July 28- August 1. We look forward to visiting with each of you.

This year we have 44 schools involved in the Young Farmer program. I hope that we can increase the number of members and chapters over the next year. I continue to believe that every program should have adult education. I also believe that the Young Farmer program provides an excellent opportunity to support your local FFA chapter and hold community activities in order to make your community aware of your existence. Hope your summer goes well.



The Texas Young Farmers provide up to \$8,000 in scholarships each year. A \$2,000 scholarship is given through the Texas FFA Foundation, five \$1,000 scholarships are given to FFA students in schools that have a Young Farmer Program and a \$1,000 scholarship is given to the Grand Champion Agriculture Mechanic Project at the Houston Livestock Show if there is a Young Farmer program at that school; if not the chapter receives \$500. This year presented \$500 to Kendal County 4H as they do not have a Young Farmer Chapter in Boerne ISD.

#### From the Ashes With Young Blood

The Bryan Young Farmers had a long history of support from the Bryan FFA. The Bryan ag department was adorned with their successes. That all came to an end as the elder ag teachers began to retire in the midnineties. One day the treasurer came in with a check made out to the Bryan FFA and said deposit this in the FFA account, we are done.

I had been teaching in Bryan for sixteen years and was not prepared for this. My young teaching partner had wanted to start a booster club so I let her take that concept and run with it. This organization was made up of, as you would expect, parents of current students. Their purpose was to support the Bryan FFA chapter. For about five years they cycled in and out but we always had their support.

During this time, several of my graduates wanted to be a part of a group to give back. I asked them to participate in the booster club. They went to several meetings and then told me "We need to talk!" They expressed to me that they were not accepted as adults even though most of them were now in their twenties. They felt as if they had no future with this group, but they still wanted to grow individually and support the program that nurtured them.

In November of 2000, this group of former Bryan FFA members re-chartered the Bryan Young Farmers with a goal of continuing their education in agriculture, further enhancing their leadership development and supporting their FFA Chapter. The first available State Young Farmer Convention for them was held in January of 2001. They were called the youngest Young Farmers in the state. They began to make their mark. Area and state activities became important to their growth. Attendance at the state convention armed them with a desire and passion for the Young Farmers. They were graciously accepted at functions as adults. Carrie Bates Halpain and Jason Benson have risen to the office of State Young Farmer President. They are inspirations to our members. Even though they are in their thirties, which is still young, we are constantly trying to motivate our eighteen year old graduates to be a part.

The Bryan Young Farmers is not a large or dominant group in our community but they are striving to grow and influence more young people. An earlier article recalled the Bryan Young Farmers struggle to establish a kettle corn fundraiser that would provide funds for scholarships for FFA members. This is such a priority that all Young Farmer activity expenses have been personal responsibilities of the attending members. This year the Bryan Young Farmers have expanded their support from Bryan High School to also include a second high school, Rudder. We hope to gain graduates from both schools as members in the future.

I have shared our struggles and triumphs. I don't have the answers to our State Convention participation decline and I don't pretend to know the struggles of other Young Farmer groups across the state. As a former ag teacher, current lead advisor to the Bryan Young Farmers and cochair of the host committee for the 2015 and 2016 State Young Farmer Conventions to be held in Bryan, I would like to continue to encourage you and challenge you as I did at the convention in San Antonio. We are the solution to the strength of the Texas Young Farmers and we owe it this organization to motivate and instill passion in the next generation. Let's work together with our officer teams to do that these next two years. The State Young Farmer Convention is that important!
