Have you ever struggled talking about a subjector just felt uncomfortable discussing certain topics? One topic we know, and can always relate to, is the holidays. We could talk for days about what Thanksgiving represents, because we learned its history in elementary school. Is this subject so easy to talk about because of our experiences?

In my case, it is; I draw on the past and feel quite comfortable with discussions on which I have knowledge. I know many of my friends and agricultural science teachers are wellversed and eloquent in public speaking, both in large and small groups. Let's try to put knowledge, which can help us and our programs, in our teacher toolbox.

The legislative session is just around the corner and hopefully we are making the contacts that will influence the decisions of Career and Technical Education. Believe me, special interest groups are!

A letter was sent to chamber leaders updating them as to the TAB State Legislative Agenda.

"Following is a late addition to the TAB State Legislative Agenda for 2013 in the area of education that we wanted to make each of you aware of since a major effort will be made by TAB in the next session."

"TAB believes these initiatives represent positive changes that can be undertaken by educators to provide greater control to local districts to operate how they see fit, empower parents (and taxpayers) at a higher level, and 'expand' the classroom to leverage available resources throughout the state to provide all children with greater access to the broadest range of subjects and the absolute best instruction possible. This will lead to a stronger system, greater educational achievement and a stronger workforce for the businesses we serve."

This sounds great and it is doing everything that the taxpayers of Texas have asked for, or is it? If you are a member of the local Chamber of Commerce, then you may be asked to support their initiatives. At least one Chamber of Commerce is asking questions. To fill your teacher toolbox, let us dig deeper into how they plan on accomplishing their goals.

This group believes that to make Texas schools better, more accountable and to increase the supply of high performing schools, Texas should:

- Enhance charter schools by removing caps.
- Parent trigger for campus charters.
- Home rule school district charter. (Increase the exemption from state mandates for home rule district mandates.)
- Scholarship for excellence. (If a student was enrolled in public schools the prior year, they would receive 60 percent of the state and local funds to enroll in a private school.)
- Expand the Public Education Grant to allow all Texas students to attend any public school in the state.
- Expand online course availability.



- Eliminate the 22-1 student/teacher ratio for any class using learning technology.
- Evaluate pay schedules.
- Allow districts to establish teacher evaluation and employment criteria (including measures of student achievement) to identify and retain effective teachers, and to retrain or remove ineffective teachers.
- Eliminate the state educator salary

schedule and allow (but not mandate) districts to adopt local schedules.

• Expand alternative certifications. (Professionals, with college or advanced degrees and years of experience in their fields, can teach in the classroom by attending an intensive six week course, passing a short test, and being approved by a principal.)

As experts in the field, teachers should reflect on this group's agenda and determine the best solution for public education. If vouchers are so great, then why hasn't Texas given public schools all the same breaks as private or charter schools? Public schools are not allowed to discriminate against who they enroll. Is this true of private schools? The data is available; have charter schools outperformed public schools with only a group of select students? The group does have some points worth considering but the same negative agendas against poor quality education and poor quality educators concern me.

We have many low socioeconomic disadvantage students and minority students who either could not afford to travel with the team or because of other concerns did not feel comfortable leaving their home turf. The ones left will have to settle for less because of supply and instructional cuts and will settle for less than standard facilities and equipment. Remember we will have to advertise this to our prospective students in order for them to make an informed decision on their school of choice.

At the end of the year teachers are evaluated on their ability to make do with what they have and educate the students who are left. Based on the outcome we may be rewarded with a pay raise or terminated. Does the career ladder come to mind? We may even choose to go to a school that has the select students if they will have us based on our past performance and our school's performance.

Due to the frustration and blame some prospective teachers may change their career path, which will lead to a shortage of teachers. But the plan has that covered. An intense six week short course will have ample replacements ready to send to the low achieving school, because at the current time Utopia High School does not have vacancies.

Our schools are not broken, but they are in need of repair. Educators need respect; the schools need the resources and tools to get the job done. Students deserve the best education at all schools and not just at select neighborhoods chosen by special interest.

Please add this discussion to your toolbox. Only you will make a difference while talking to your friends, fellow educators, business leaders and legislators.

TRS Report Released

During the last legislative session, TRS was mandated to conduct a study on the effects of possible changes to the current defined benefits plan. TRS completed the study and released the results on Sept. 1, 2012. The full report can be found on the TRS website (www.trs.state. tx.us). This update will hit the high points as included in the Executive Summary. The eight major findings are:

- 1. "While the TRS pension fund can pay currently projected benefits through 2075, the state needs to begin addressing the unfunded liability. Delays will only increase costs."
- 2. "The value of the retirement benefit available to TRS members is 36 percent less than the average benefits available to members of peer systems."
- 3. "The defined benefit plan provides current benefits at a lower cost than alternative plans."
- 4. "The majority of TRS members will do significantly worse investing on their own in a plan with a defined-contribution component."
- 5. "Alternative plan structures carry differing levels of risk for the State and TRS members.
- 6. "Other systems changing structures have lowered benefits to realize savings."
- 7. "Moving new hires to an alternative plan will not eliminate existing liabilities."
- 8. "Approximately, 95 percent of public school TRS members do not participate in Social Security, leaving the TRS benefit as their only lifetime annuity."

Most of the findings were readily apparent even before the study. With an aging workforce and lower investment income, there may be a call for increasing the contribution from members and the state, currently at 6.4 percent each. The fact that the available retirement benefit is 36 percent less than many other systems is easily understood by the retirees who have not received an increase in their monthly check for over 10 years.

The current benefits are cost-effective and investments have a great advantage in economy of scale. Individual investors would almost assuredly do worse. The risk on each investor would be greater compared to the current system. The primary way other systems have saved money was by lowering benefits. Existing commitments by TRS would be unaffected by moving new hires to a different

system. Without Social Security providing a safety net for most of our retirees, a defined contribution system could provide a less than dignified retirement.

The study seems to make a great case for maintaining our current system, but remember the legislature has ultimate control of this issue. Don't neglect to contact your State Senator and State Representative to voice your opinion. This is big business, and special interest groups will have their say. In 2011, TRS paid almost \$7.2 billion in retirement benefits. This issue is not over, and there will be detractors that will discount the study as self-serving. I will keep you posted.



What's Happening with Texas FFA?

The Texas FFA Board of Directors will be studying a number of issues vital to the organization through its board committee process.

Texas FFA Board operations policies mandate a number of standing committees to address normal recurring decisions, such as budget formulation, human resources policies and convention speaker selection. Typically, these committees are comprised of both adult board and student board members. The board chairman has the discretion to appoint ad hoc or special committees to study specific issues and make recommendations to the full board of directors.

In June, outgoing chairperson Sandra Choate appointed a special committee to consider the appropriate response to egregious livestock show violations. One of the constitutional mandates for maintaining FFA membership is to "Display conduct consistent with the ideals and purposes of the Texas FFA Association/Texas Association of Future Farmers of America. (Texas FFA Constitution, Article V, Section C(4).)" Clearly, a serious ethics violation while as an FFA exhibitor would not be consistent with displaying "conduct consistent with the ideals and purposes of the Texas FFA Association." However, there is currently no companion operating precedent or policy to the constitutional language which implies some response from the state FFA association.

"I believe the consensus of the board is that our intent is not to punish, but to create a serious teachable moment," says Texas FFA Executive Director Tom Maynard. "But there is also a sense that Texas FFA should not be silent when these things happen."

Any action taken will require some type of due process and will require a thorough study of previous legal precedents. In the 1990's, the Texas Agricultural Education Director and State FFA Advisor revoked FFA memberships in a stock show-related ethics incident and spawned a number of lawsuits which were not settled until nearly a decade later.

Texas FFA will also continue to study the Texas FFA student delegate process. The intended outcomes of the study are twofold. First, the size the of the delegation has outstripped the capacity of certain venues to contain the delegate body in a defined delegate area. Second, there is a growing body of evidence that members are not adequately prepared to participate effectively in a delegate process and that efforts should be made to make the experience

more meaningful and instructive.

A task force of board members, teachers and student officers will study different models practiced in other FFA associations and in organizations outside of the FFA.

"There is much we can glean from other organizations," says Maynard. "Keep in mind our graduates are likely to participate in delegate processes for professional and governmental associations and political parties. We should prepare them to be effective participants and leaders by creating processes that foster hands-on learning."

The task force will also study the extent to which students are engaged in meaningful self-government in the subordinate administrative subdivisions of the state associations--districts and areas.

"We shouldn't be surprised that our students don't know how to apply parliamentary law in a real delegate business session at the state level if they have never actually done it before at the chapter, district or area level before they stepped onto our delegate floor," Maynard says.

"We have to be intentional and strategic in creating processes consistent with the 'learning by doing' model," he says. "Chapter, districts and areas should be conducting business beyond the election of officers and creating experiences that not only prepare them for the state process, but also for a life of influence in their community and state."

The task forces' goal is to have a draft recommendation by early spring in anticipation of proposing constitutional amendments to be presented at the 85th Texas FFA Convention in Dallas. The delegate seating in Dallas is flexible since the arena seating in that venue can be adjusted. The convention returns to Fort Worth in 2014 with a finite amount of floor space for delegates and no real viable alternative for creating separate delegate areas.

Texas FFA will also make a thorough study of the current convention housing and registration processes.

A board appointed committee will study the current process of blocking contracted housing and earning rebates that offset convention expenses and generates complimentary room nights for volunteers and contractors. Many advisors have indicated they would rather pay a higher registration fee than be required to navigate a housing bureau. If the board followed that sentiment, it would require a technological solution that would give Texas FFA the ability to integrate housing and registration.


Another discussion issue is "who pays?" Currently, only the students bear the financial burden of paying for convention, but many other participants enjoy the benefits of the production and trade show, which is a \$400,000 to \$500,000 budget item. All students pay the \$35 registration fee, even if they are only present for one session to receive an award or scholarship. A different model might be a universal registration fee paid by any and all attendees, which could be lowered for all groups staying in the housing block and slightly higher for all groups outside the block, along with day passes for oneday participants.

Any changes to housing and registration would not take effect until 2014 or later.

It is thanking God for the creative ideas that enrich life by adding your own creative contributions to human progress... *thank you for all you do.*


It is thanking God for each new day *and by living it to the fullest.*

It is adding to your prayers of thanksgiving, *acts of thanksliving.*



It's a Changing World for Adult Support Groups Too

GASB AND YOUR SUPPORT ORGANIZATION

Adult support groups will need to establish their own tax exempt status as independent organizations and may be subject to auditing as a part of the school district's annual audit – all due to tougher audit standards and additional guidelines to determine whether organizations qualify as component organizations.

The Governmental Accounting Standards Board establishes standards for auditing governmental entities including school districts. In the wake of recent corporate scandals—Enron and others—GASB handed down guidelines which further define what is a component unit of the school district and consequently must be included as part of the district's annual audit and which must be cut loose and operated as an independent organization with its own tax exempt status.

WHAT DOES THIS MEAN FOR YOUR SUPPORT GROUP?

Your school district will likely contact you or your support group leadership requesting information concerning revenues, assets and the amount of money spent on behalf of your schools students or employees to determine if the organization's expenditures are "significant and material" to the district. If deemed so, your organization will have additional reporting requirements to comply with the district's audit requirements to avoid audit problems which could potentially lower the school district's bond rating or TEA financial rating. It also means that it can no longer use the school district's tax exempt status, Employee Identification Number (EIN) or bank accounts.

WHAT DO WE DO?

Tax Exempt Status If your local FFA support group does not have its own 501(c)(3) tax exempt status, your school district will likely require you to establish this with the IRS by filing articles of incorporation and bylaws with the state secretary of state's office and applying for tax exempt status and a EIN from the IRS. Unfortunately, this is an expensive, time consuming process and will be a daunting task for many campus support groups. The good news is that as an FFA support group, your organization can use the FFA's tax exempt group number by completing a short one-page document that can be downloaded at the bottom of this page. Please complete the form and fax it to the Texas FFA office at 512-617-8219. This is necessary as the state and national organizations must know who is using this group number.

Employee Identification Number (Federal Tax ID)

Getting a federal number by filing an SS-4 is relatively easy and can be done online, over the phone or the oldfashion way—on paper. The online version can be accessed via the IRS website: www.irs.gov. On the sidebar to the left is a search box. Enter "apply online, EIN" and in the search results you will find the link to the online employer ID number. Follow that link and scroll down to the "Apply ONLINE NOW" link. This brings up the application. Note that the application does not accept any punctuation except hyphens and ampersands. You will not need to complete all blanks—just the applicable ones: 1,3, 4a, 4b, 6, 8a-(other) 10, 14 (other) and the name, title and phone and fax numbers. Under 8a, you will need the Group Exemption Number (GEN). Please call or e-mail the Texas FFA office to get that number. You will get your EIN within 15 to 20 seconds after submission. Record this number on paper immediately, before printing or saving the page. If you lose that page, it will be four to five days before the IRS can access it. This process can be accomplished via telephone at 800-829-4933, option 1 or by downloading and mailing form SS-4 available for download at: http://www.irs.gov/ pub/irs-fill/fss4.pdf.
